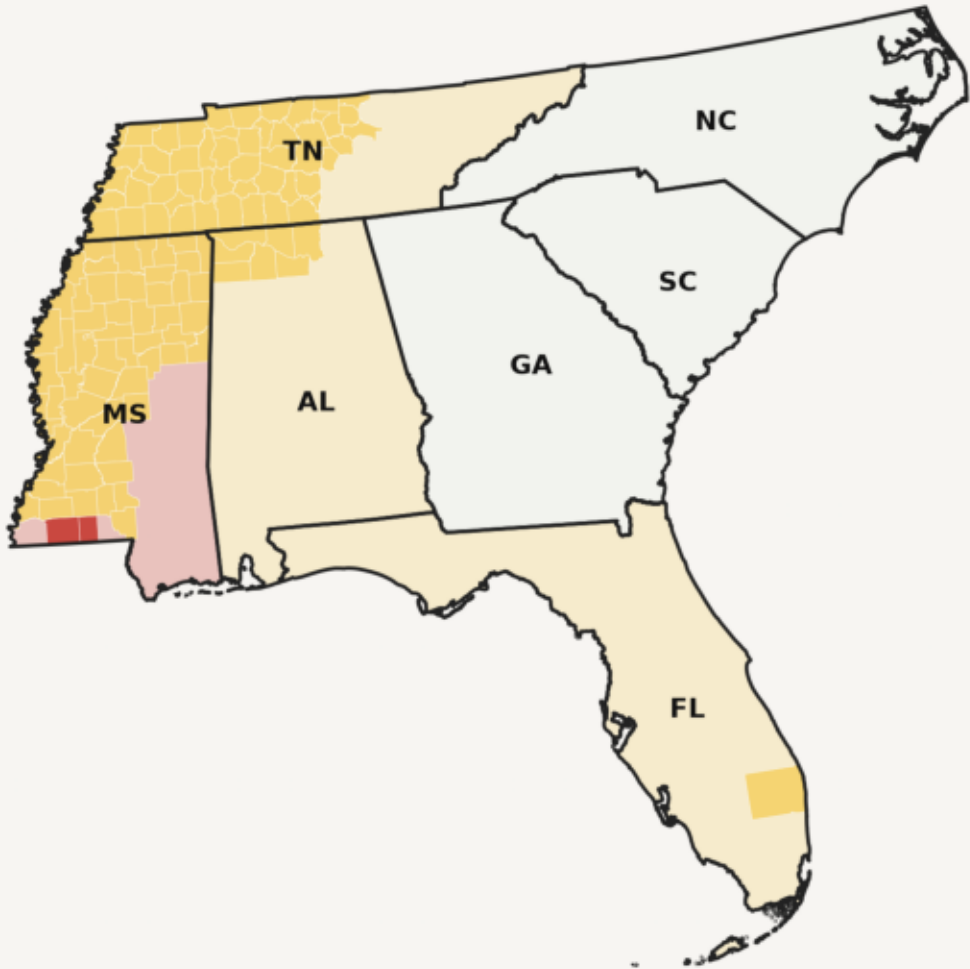

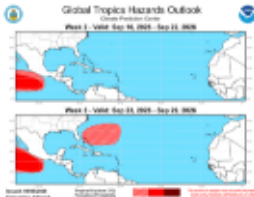

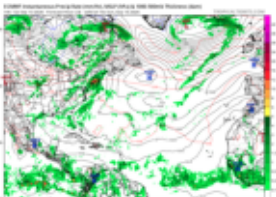

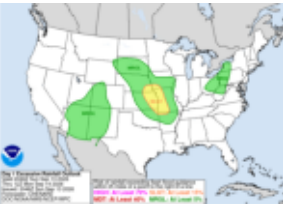
GFS North Atlantic Model Guidance

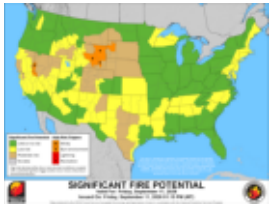

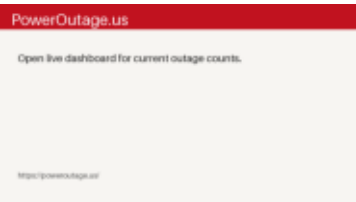
7-Day Significant Fire Potential

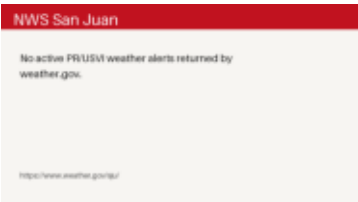
